

END-USER LICENSE AGREEMENT FOR everywhereIQ with moniq. PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM. everywhereIQ with moniq is developed in close collaboration with PhD Kim van Muster, under supervision of dr. Cyriel Ponsoen. End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and everywhereIM Ltd. For the everywhereIM software product(s) identified above which may include associated software components, media and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA.
